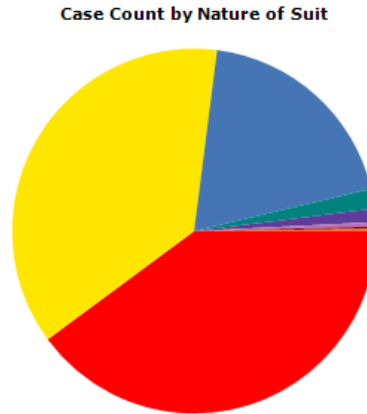

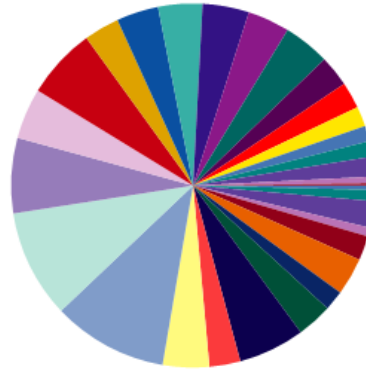

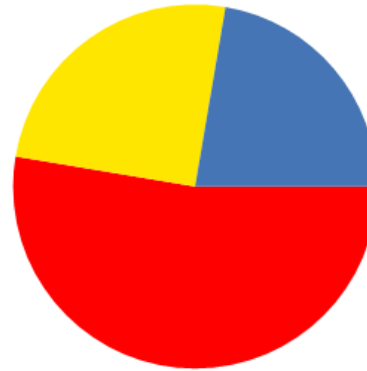

Case Count by Capacity

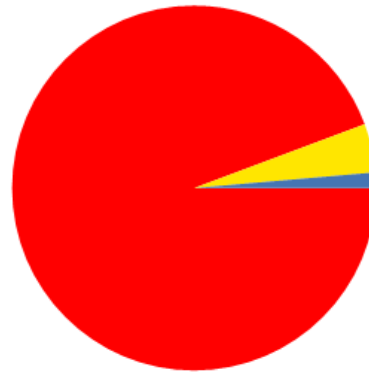

Case Count by Judgment Data

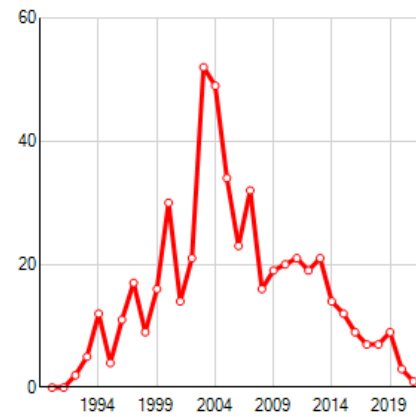

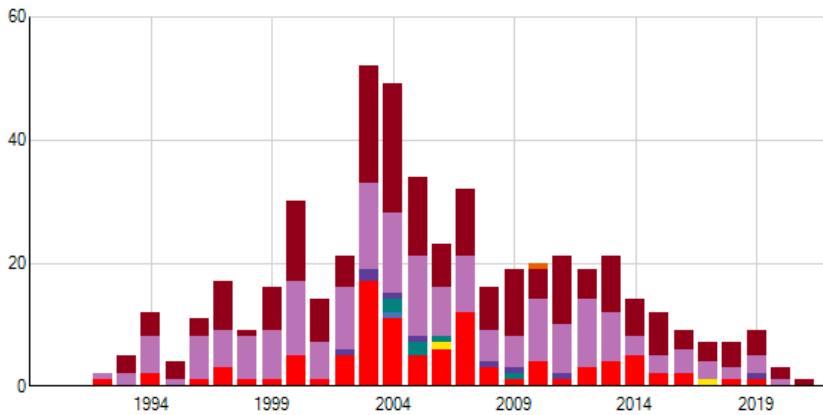

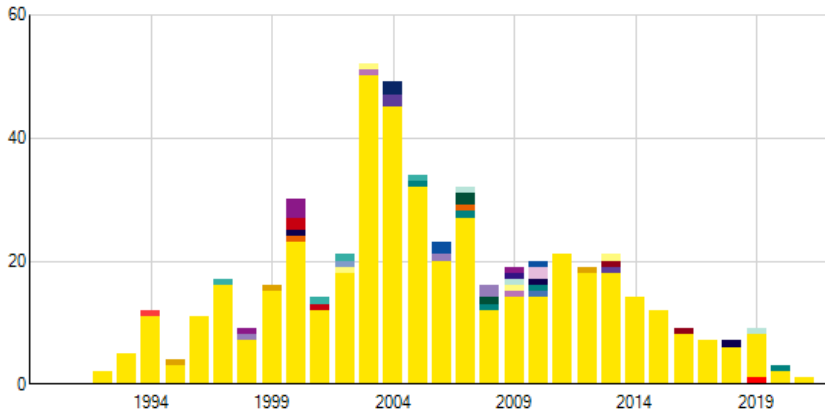
